These include the 7 amendments to Inland Revenue Ordinance, 3 amendments to Stamp Duty Ordinance, 2 new Inland Revenue DIPNs (DIPN 61 & 62) and 6 revised Inland Revenue DIPNs, 5 tax cases and 3 penalty cases occurred in the aforesaid period.
